We build these apps and resources with low-resource settings in mind and so try to make them as simple and low-powered as possible. We also try to provide downloadable offline resources where we can. The data management portal has been developed to provide support to researchers to ensure that high-quality data management is fully considered, and planned for, from the outset and throughout the life of a research project. In order to interpret the extensive list of repositories recommended by journals and funders, the open access FairSharing ontology was applied to filter by subject areas related to health, based on metadata from re3data.org. Other metadata fields from re3data.org were used to facilitate building the repository finder. This metadata includes the keyword 'FAIR' for those repositories that have been assessed as FAIR within the re3data.org database. However, participants from outside sub-Saharan Africa, the European Union or one of the Countries Associated to Horizon 2020 are not automatically eligible for funding and should fund their own participation in the project. This funding can be from any source. Potential participants from these countries are therefore encouraged to contact research and innovation funding organisations in their own country to seek support for their participation in EDCTP Calls for Proposals.	EDCTP supports research in sub-Saharan Africa and so our funding is open to researchers in Europe, SSA and countries that are associated to H2020. India is not included but we do have some projects that include partners in India.
