Ethics of Data Science in Global Health Research: Case Study & Practical Examples

There are also ethical implications specific to data science in global health research, including those related to data collection, use, and sharing. Practical examples of how ethical issues in global health data science and research are being considered may be found in the work of TGHN's regional partners: Fiocruz (Latin America & the Caribbean), icddr,b (Asia), and Africa CDC (Africa).
