# Preparing for the 2026 dengue season: Insights from predictive models

This webinar will present the 2026 dengue forecasts for Brazil, based on results from the Infodengue–Mosqlimate Dengue Challenge (IMDC), a collaborative initiative that brought together 52 researchers from 15 international teams. Discussions will explore how predictive modelling can enhance dengue surveillance and inform public health planning in the country.

# Applications open for the University of Oxford's fully online part-time Postgraduate Diploma in Global Health Research

The course is based on the evidence-led Essential Research Skills Training Curriculum for Health Research which was developed as a collaboration between The Global Health Network, UNICEF, the United Nations Development Programme (UNDP), the World Bank and WHO Special Programme for Research and Training in Tropical Diseases. The programme is based on a study that involved over 7,000 participants from 153 countries. This makes the diploma the first of its kind where all the core skills and component steps identified to undertake quality, practical and appropriate health research studies are covered, making it relevant for research into any disease, in all types of studies, and in any setting.

This part time course is suitable for busy professionals who want to keep working or cannot travel, and aims to tackle inequities in health research leadership. Learn more:
