This project focuses on two intervention areas in selected countries; 1) Support the increased role of the non-public sector in delivering quality TB and TB/HIV services and 2) Strengthen implementation of Global Fund (GF) supported grants.

Purpose of the position

As Global Fund TB Advisor you will:

- Provide long term technical assistance (LTTA) to the Swaziland National Tuberculosis Control Program (NTCP) with a primary focus on TB and TB/HIV activities funded through the Global Fund grant;
- Provide programmatic, technical, and management support to the NTCP to ensure smooth running of the grant in meeting agreed upon targets, benchmarks and conditions precedent;
- Assist the NTCP to ensure effective coordination of NTCP GF supported activities;
- Assist the NTCP in close monitoring GF supported activities, review program information on a regular basis and identify issues that may lead to implementation delays;
- Identify any needs that the country may have regarding targeted external technical assistance;
- Liaise closely with the National Emergency Response Council on HIV and AIDS (NERCHA), the GF grant Primary Recipient (PR), WHO and other partners;
- Depending on specific technical capacities, you may also be requested to provide direct technical support to address gaps identified.
